R E F:

The Director of Higher Education has submitted a list of applications received for opening new Degree Colleges during 1984-85 stating the conditions already fulfilled by the sponsors/promised to be fulfilled the conditions stipulated for opening new Degree Colleges in G.O.Ms.No.306 Edn., dt.19.7.1983, together with her recommendation based on the Inspection Reports of the concerned University/the concerned Regional Joint Director of Higher Education

2. Govt. after careful consideration of these applications and the particulars furnished therein, sanction the opening of the Govt. Degree Colleges as mentioned in the Annexure. to the following conditions within a period of one year from the date of this order, not already complied with:-

1. The College Committee should obtain the feasibility report from the concerned University and submit the same to Govt. through the Director of Higher Education immediately if not already submitted.
2. The college Committee should credit an amount of Rs.4.75/2.50 lakhs as the case may be as required under the G.O. read above, towards salaries, equipment etc., into the Govt. account under the receipt Head, "077.Education-E. University and other Higher Education-M.H.15.Other receipt -S.H.(01)-Contributions and income from Endowments(to be opened)", if not already deposited.
3. The College Committee should provide 15 Acres of land and building with plinth area of 8,000 sq.ft. and register the same in favour of Govt.
4. The college Committee should provide adequate temporary accommodation exclusively for Degree Classes from their own funds.
5. The College Committee should construct permanent building for the college from their own funds within a period of 5years at the latest. They should form a committee consisting of parents and others to raise adequate public contributions for construction of buildings as per the approved plans.
6. The College Committee should provide furniture, equipment and library books etc. immediately as prescribed by the University concerned.
7. If the existing Govt. Jr. College is to be upgraded into Govt. Degree College, the Junior and Degree Colleges Sections shall exist separately either within the same premises respectively, in which case the college committee will have to provide necessary accommodation exclusively for the Degree College and also facilities like library, equipment, furniture etc.,

8. The post of Principal of the Junior College shall continue since the Govt. Jr. College and the Govt. Degree College will function independently.
 9. The College shall start with one section each in I Year B.A., and B.Com. courses and one of three optional subjects shall be restructured course, as approved by the University
 10. The medium of instruction should be Telugu, English medium can also be opened provided there is a minimum strength of 30 students in the course concerned and with the prior permission of the Govt.
 11. The College committee should get affiliation to the college from the concerned University expeditiously.
3. The Govt. also sanction the creation of the following teaching and non-teaching staff to each of the colleges shown at Annexure- to this order as specified below.

The above posts shall carry the usual pay and allowances admissible as per rules except for the part-time Lecturers post with a consolidated pay of Rs.400/-per month. The posts of Physical Director and Librarian shall not be filled during the current year 1984-85.

Pending posting of regular staff, the Director of Higher Education is requested to issue instructions to the Principals concerned to make part-time arrangements of teaching staff on the basis of "offer of remuneration" for giving lectures on hourly basis. The recruitment in respect of non-teaching staff shall be made in accordance with the existing rules.

4. Sanction is also accorded for incurring non-recurring, expenditure of Rs.50,000/- (Rupees Fifty Thousand only) towards furniture, books and other contingencies for each of the years 1984-85, 1985-86 and 1986-87 for each of the colleges specified in the Annexure to this order.

5. The expenditure on these colleges shall be met from the additional provision to be made in the plan budget for the current year and shall be debited to the Head of Account:

"277. Education-E, University and other Higher Education-
M.H.10.Govt. Colleges-Scheme included in the Plan-S.H.
(010) Salaries.040/044. Other office expenses-150
Machinery and equipments."

6. The Principals of these colleges are permitted to incur the expenditure under contingencies within the ceilings specified above.

7. The Director of Higher Education shall ensure that the college Committees fulfil all the conditions mentioned in para 2 above and also the conditions laid down in G.O.Ms.No.306 Edn. dt.19.7.1983 within one year from the date of this order.

8. The Director of Higher Education shall appoint an Expert Committee regionwise immediately to go round all the colleges sanctioned in this order to verify to what extent the respective sponsors have fulfilled the conditions laid down in G.O.Ms.No.306 Edn., dt.19.7.1983 and the time schedule within which they can fulfil these conditions and submit report with 2 months.

If on the basis of the Expert Committee report, wherever a college is found not viable in terms of students strength and infrastructure facilities available action will be taken to close down such an Institution and accommodate the students of that college in the neighbouring institutions.

HIGHER EDUCATION DEPARTMENT – Government Degree Colleges – Introduction of 'Science Courses (Conventional) in 20 Government Degree Colleges in the State from the academic year 2008 – 09 – Engagement of Teaching and Non – Teaching Staff on 'Contractual' and 'Outsourcing' basis respectively – Sanction – Accorded - Orders – Issued.

ORDER: -

In G.O.1st read above, Government have accorded administrative sanction for starting 'Science Courses' (Conventional) in 20 Government Degree Colleges at various places in the State from the academic year 2008 – 09, keeping in view the student strength of the respective Colleges and available accommodation and other necessary aspects, by meeting the expenditure by way of re – appropriation.

2. The Commissioner of Collegiate Education, A.P., Hyderabad, in his letter 2nd read above, among others, while insisting the need for sanction both teaching and non – teaching posts has informed that there are no surplus posts available in both Government / Private Aided Degree Colleges to adjust against the newly sanctioned 'Science Courses', or even for the engagement of Contract Faculty or Guest Faculty. He has therefore, requested the Government to take a view for the sanction of the required Teaching and Non – Teaching posts to each college, in order to provide necessary instructions to the students admitted into these courses.

3. Government after careful examination of the matter in detail, hereby accord sanction of the following 05 (Five) Teaching and 10 (Ten) Non – Teaching posts to engage on 'Contractual' and 'Outsourcing' basis respectively [to each Government Degree College], as per the remuneration fixed against each post(s) in 20 Government Degree

Colleges wherein 'Science Courses' were introduced newly from the academic year 2008-09, with the remuneration fixed against them, subject to meeting the expenditure within the budget provision only: -
